NOTICE

Sub: Concluding of FSAs by existing linked consumers of SECL; last & final Extension

Further to our notice no. SECL/BSP/S&M/COMM/150/NCDP/1604 dated 09/11.06.2008, all concerned are hereby informed that;

- 1. The period for execution of FSA under New Coal Distribution Policy (NCDP) for Non-Power Utility valid linked consumers has been extended up to 31st July 2008. Whereas for Power Utilites, the extension is up to 30th September 2008.**
- 2. This being the last and final extension, after lapse of extended period, these consumers will not be able to book fresh quantities without execution of FSA beyond the stipulated period.**
3. As regards the conditions relating to quantity & price of coal, the Terms & Conditions already notified vide Notice No. SECL/BSP/S&M/COMM/150/NCDP/1319 dt. 14.05.08 shall be applicable.
4. Updated status of FSAs after considering the position up to 30.06.2008 is being placed on SECL website www.secl.gov.in also. All existing valid linked consumers of SECL are requested to carefully check their status and other particulars.
5. All consumers, whose FSAs are pending due to any reason are requested to ensure to conclude their FSAs well within the extended period upto 31.07.08. Wherever there are any deficiencies in Security Deposit and/or documents, the same must be rectified forthwith. Consumers may contact SECL, Kolkata office and FSA section, S&M department, SECL, Bilaspur for BG and documents related issues respectively.

It is again clarified that no further notice will be given by SECL in this regard and in the event of failure to conclude FSA (OK Status), due to any reason, including any deficiency relating to BG and/or documents, within the extended period, i.e up to 31.07.2008, it will not be feasible for such consumers to book any fresh quantities, without execution of FSA, as per directives of CIL and SECL will not be responsible in any manner for the same.
